Squash New Zealand Poipātū Aotearoa 'Squash Squad' Promotion 2024 Terms and Conditions

- 1. Information on how to be entered into the draw, how winners are chosen and prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
